

Meetings:

12 Executive Committee Meetings and 2 Emergency Executive Committee Meetings were held during the tenure. Attendance of most of the members was mostly satisfactory which shows their commitment towards OBA. Most of the Executive Committee Meetings ended with a delicious dinner sponsored by the Executive Committee members on a rotation basis.

Special General Meeting:

SGM was held on 12th May 2024 at Ghafoor Hall to elect three OBA members to Board of Governors. Record 508 members attended the meeting and Mr. Malik Hanan was the Presiding officer who conducted the meeting with steady composure and with a sense of professionalism. 5 candidates contested the election and 3 were elected based on highest number of votes namely, Mr. Fouzul Hameed, Mr. Jawfer Us Sadiq and Mr. Nuzri Munsoor. Other two candidates were Mr. Shafraz Salem and Mr. Aufer Johar. All the attendees were served with refreshments in the morning and lunch packets at the end of the meeting.

Courtesy Meeting with Principal

It is a custom for OBA Executive Members to meet principal after AGM and exchange the ideas for the betterment of the OBA and college. This meeting was held on 24th of June 2024, at office of Principal and President of OBA introduced the new team to principal and updated the projects planned to do by OBA. PROJECTS

1. GREEN FOR ALL Community Project

OBA intended to do a community project and Mr. Shafraz Salley was appointed as Project Chairman and Mr. Yufliq Kabeer as Co Chairman. They came up with the plan to execute a project at Sinharaja forest aiming to plant tree species. 38 members from OBA Ex Co and affiliated bodies started the journey morning 6.00 am to Sinharaja Forest on Sunday 28th of July 2024. 2. Free Medical Health Check up

Free Medical Health check-up was conducted under the Project Chairman Mr. Falul Hashim on Sunday 29th September 2024 at Swimming Pool Complex. Dr. Mohamed A. Afzal who is an OBA member coordinated with doctors and nurses and brought around 12 expertise for performing this free service. The following services were done during this medical camp,

Nearly 130 OBA members, their families and Teachers participated in this program and everyone appreciated the service for doing FOC otherwise it would have cost more than Rs 8,500. All doctors and nurses were provided with delicious lunch and token of appreciation

3. Free Swimming Pool access for OBA members

To encourage greater engagement of our Old Boys with the Swimming Pool facility, special permission was obtained from the Principal to allow free access to OBA members on every Poya Day, starting from 19th August 2024. This initiative aims to promote health, fellowship, and active involvement among our members.

4. TECH Workshop

President Mohamed Cassim proposed this initiative with the aim of creating a professional development platform for our Old Boys by offering free technical courses.

The Electrician Training Course (NVQ Level 3) commenced on 6th October 2024 at the Swimming Pool Complex Auditorium, offered free of charge to OBA members. This comprehensive five-month program was inaugurated with a special guest lecture by Mr. Deepthi Bandara, Manager at ACL Cables, who conducted a half-day session focused on different types of electrical cables, accompanied by real-life samples. Over 20 members actively participated and gained valuable knowledge.

As a token of encouragement, ACL Cables awarded certificates and caps to all attendees.

The course was conducted by Mr. Ehab Nizam, a certified VTA Training Assessor and a proud Zahira Old Boy. We extend our sincere gratitude to him for his dedication and for conducting the entire five-month course voluntarily, without any charge.

9. College Tie

Project was started with the intention of stopping this practice and everyone to wear same. It was decided to sell the new tie at the discounted price when someone returns the old tie. 10. WIZDOM Education Fair

OBA has initiated first time this sort of Education Fair and it is branded as WIZDOM. Shakthi TV / Shakthi FM agreed as Media Partner for the project and have given us good publicity through their channels. The Principal, OBA President and Project Chairman Mr. Ifras Kamil participated in a Shakthi TV program in promoting the event. OBA able to get around 25 Educational Exhibitors both Private and State. Many schools were invited to participate in the AL seminar and Art Competition.

Press Conference was held prior to the event on 31st January 2025 at Zahira College Swimming Pool Complex Auditorium. Many media personnels attended the conference and all the sponsors were recognized in the function. The Principal and Project Chairman gave a briefing about the Education Fair

The event day 7th of Feb 2025 Opening Ceremony was arranged with a Chief Guest Mr. Kamal Ariyasinghe, Additional Secretary to Ministry of Education. Guest of Honors were Mr. P.R. 14. Solar Street Light

Another unique initiative undertaken by the OBA is the installation of solar street lights in selected areas within the College premises and in Maharagama grounds. President Mohamed Cassim and Project Chairman Mr. Farzan Sahabdeen, in consultation with the College administration, identified the key locations. The sponsors have provided all necessary equipment, and installation is scheduled to take place shortly.

15. Amendments to Constitution

The project was started with the intention of going through the complete constitution and identifying grey and ambiguous areas and then to rectify it. Also adding and removing certain areas for the betterment of OBA, considering long term use. Mr. Ashroff Rumi was appointed as Project Chairman with few exco members, and the team had many meetings and extensive discussion took place before finalizing. The proposed amendment was presented to Exco on 18th Feb 2025 and further revision was done with the input from Exco. It was decided by the Exco to present these amendments to the general members through SGM

16. Letter of Appointment

All Executive Committee members were issued an official appointment letter, signed by the President and Secretary, to serve as documented proof of their position. This initiative aims to provide members with formal recognition of their role in the committee, which can be used for future reference and acknowledgment.

17. Appreciation Letter

All Project Chairmen is given an appreciation letter for successful completion of the project by recognizing their effort and leadership

18. Introducing WhatsApp Channel

The OBA recognized that members were not receiving timely updates about OBA and college activities. To address this, a dedicated WhatsApp channel has been created, enabling members to stay informed and connected with ease.

19. Priority Membership Card

Currently, members primarily use their OBA membership cards only once a year, mainly during the AGM. To enhance its value and encourage year-round use, we have introduced the **OBA Priority Card.** This card will enable members to enjoy discounts at selected outlets. The initial phase of the project has been completed, and we anticipate launching the card in the coming months.

20. Sports Complex

The "Zahira Sports Complex" was initially launched during the 2014 Fellowship Dinner under the Chairmanship of Mr. Jisthy Fawmy. There was a hold during COVID 19 and cost has doubled compared to originally estimated. The project was re-designed by a new architect

In spite of many challenges, Construction continued with the guidance from Chairman Mr. Fouzul Hameed and complex is expected for soft opening by June 2025.


